

Albertsons®Companies 2017 Souper Bowl of Caring Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. BACKGROUND:** Albertson's LLC ("Sponsor") sponsors the Albertsons / Tom Thumb 2017 Souper Bowl of Caring Sweepstakes (the "Sweepstakes") at Albertson's stores owned and operated by Sponsor in Texas & Arkansas (excluding El Paso) (each a "Participating Store"). The Sweepstakes begins on January 8, 2017 at 12:01am CT and ends on January 31, 2017 at 9:00am CT ("Sweepstakes Period"). All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted by law.
- 2. ELIGIBILITY:** Eligible entrants must be at least 18 years of age as of January 8, 2017 and a legal U. S. resident residing in Texas or Arkansas living within 50 miles of a Participating Store to win. Employees of Sponsor, its parent, subsidiaries and affiliates, Sponsor's advertising agencies and their agents, and the immediate family of such employees or persons living in the same household as such employees are not eligible to enter or win. LIMIT ONE PRIZE PER HOUSEHOLD.
- 3. HOW TO ENTER:** There are two (2) ways to enter.

First, during the Sweepstakes Period, for every Souper Bowl of Caring Hunger Bag ("Participating Products") purchased in a single transaction at a Participating Store, entrant will receive a limited time coupon upon checkout that contains directions on how to enter to win. Second, **TO ENTER WITHOUT A PURCHASE:** Hand print your full name, physical address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Albertson's 2017 Souper Bowl of Caring Sweepstakes", 7580 Oak Grove Road, Fort Worth, Texas 76140. You will receive one (1) entry into the Sweepstakes. Limit: One (1) entry per envelope. All mail-in entries must be handwritten and must be postmarked by and received one day prior to the Drawing Date as set forth in Section 4 below) to be eligible. Multiple entries are allowed but each must be in a separate envelope.

Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. Photocopied or mechanically produced entries or envelopes will be void. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor.

- 4. SCHEDULE DRAWING DATE:** Drawing will occur at 10:00am CT. Entries must be received by 9:00am CT on January 31, 2017 prior to the drawing date to be eligible for the drawing.

- 5. GRAND PRIZES:** Sponsor will award a total of four tickets: (2) Prizes consisting of two (2) tickets to the Souper Bowl ("Game") on February 5, 2017.

Parking, incidentals, federal, state and local taxes are the sole responsibility of the winner, however Sponsor will award each winner one (1) \$500 travel voucher for incidental costs. Approximate Retail Value ("ARV") of each Prize is \$3500.00. The total ARV of all Grand Prizes: \$7,000.00. The seating location will be determined at the sole discretion of the Sponsor.

Sponsor will award a total of four (4) 1st Place Prizes consisting of a Homegating Party package to include 1 big screen TV and a \$500 Albertsons / Tom Thumb gift card. ARV of each Prize is \$3,000. The total ARV of all 1st Place Prizes: \$12,000.00

Sponsor will award a total of two (2) 2nd Place Prizes consisting of a Tour of the Star for four people and one autographed football from a current or former Dallas Cowboy. ARV of each Prize is \$300. The total ARV of all 2nd Place Prizes: \$600

- 6. SELECTION AND RESPONSIBILITY OF WINNER:** Winners will be selected from Sweepstakes entries properly submitted and timely received. Random Drawings will be held on February 1, 2017 at 10:00am to select potential Prize winners from the eligible entries. Sponsor's decisions on all matters relating to the Sweepstakes shall be final and binding. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period.

Potential winners will be notified through the contact information provided on the entry form and will have 24 hours after first notification to claim their prize. In the event that a potential winner cannot be contacted after 3 attempts, is disqualified, or is unable to accept the prize for any reason, Sponsor may, in its sole discretion, contact the alternate winner, who will become the new potential winner. Inability of the potential winner and alternate winner to receive the Prize for any reason will result in forfeiture of the Prize.

Potential Prize winners must provide proof of residency and complete, sign, and return a notarized Affidavit of Eligibility, Prize Acceptance, Liability and Publicity Release in the form provided by Sponsor within 3 days of being sent the notification of his/her selection as a potential winner. Failure to do so will result in the forfeiture of the Prize and selection of an alternate winner. Potential winners must be certified by Sponsor as a Prize winner in writing before prize is awarded. Except where prohibited, acceptance of a Prize constitutes winner's consent to the use of his/her name, and geographical data for advertising and promotional purposes without additional compensation from Sponsor.

Sponsor, its subsidiaries and affiliates, Sponsor's advertising and promotion agencies and their agents (collectively, "Sweepstakes Entities") are not responsible for: (1) any incorrect or inaccurate information, (2) unauthorized human intervention in any part of the entry process or the Sweepstakes; (3) Game cancellation for any reason, or (4) any other computer, network, technical, human or other error, problem or malfunction that may occur in connection with the administration of the Sweepstakes, the processing of entries, or the selection or notification of potential winners. Further, if the Sweepstakes cannot be conducted as planned for reasons outside the control of the Sponsor which, in the sole opinion of Sponsor, may corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes (or portion thereof), Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes (or portion thereof). Sponsor also reserves the right at its sole discretion to disqualify the entry of any entrant found to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes; (b) violating any of the terms of this Official Rules; or (c) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person. Sponsor and Sweepstakes Entities are not responsible for claims, injuries, losses or damages of any kind resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of the prize or participation in this Sweepstakes.

By accepting any prize, the winner agrees to release and hold Sponsor and Sweepstakes Entities harmless from and against any and all losses, damages, rights, claims, actions and liabilities of any kind in connection with the Sweepstakes or receipt or redemption of the prize. The winner assumes all liability for any injury, death, or damage caused, or allegedly caused, by participating in the Sweepstakes or use or redemption of the prize.

Any disputes that may arise hereunder shall be resolved individually, without resort to any form of class action, and shall be governed in all respects by the laws of the State of Idaho without regard to the conflicts of laws principles of any jurisdiction. Further, in any such dispute, under no circumstances will individuals be permitted to obtain awards for, and hereby waive all rights to claim, punitive, incidental or consequential damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (e.g. costs associated with entering), and individuals further waive all rights to have damages multiplied or increased.

Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any provision of this Official Rules shall not constitute a waiver of that provision.
